Duties

The duties of the committee are prescribed by Government Code §27131, and include:

- Annual review of the Pooled Investment Fund Policy;
- Quarterly review of investment; and

Qualifications and Restrictions

• Annual causation of a compliance audit of the portfolio.

The Treasury Oversight Committee may not direct individual investment nor impinge on the day-to-day operations of the County Treasury.
